*Check in days/times – Monday, Tuesday, & Wednesday 9am-5pm.

*Flea Market Hours - Thursday, Friday, & Saturday 9:00am–7:00pm. Sunday 9:00am–3:00pm

***Office Hours -Thursday-Saturday 8:00am-10:00am**

THE OFFICE WILL BE CLOSED AFTER 10AM EACH DAY

Sunday 9:00am-11:00am & 2:30pm-5:00pm

*Gate Hours during the show open at 7:00am to 9am.

And Sunday 7am to 9am & at 3pm

*You may set up or restock daily, before and after the show.

NO DRIVING IN FLEA MARKET DURING THE SHOW.

*Lot size is approximately 20'x20' at \$100.00 per lot for the 4 day show.

*Lot includes 2 show passes per lot purchased

*Vendor camping off your lot is available for and additional \$20.00

*No refunds or exchanges. Checks must be valid on receipt.

*No roving vendors are allowed on the showgrounds.

ITEMS NOT ALLOWED TO BE SOLD OR HOUSED

*No food or drinks {including bottled water} can be sold unless you are a registered Food Vendor.

*No Drugs or Drug Paraphernalia of any kind, including medical marijuana or related accessories.

*No obscene materials of any kind, words, posters, clothing, signs, etc.

*No sale of live animals on the show grounds.

* No counter-fit branded merchandise or any other illegal items.

*No firearms, ammunition, arrow heads, or cross bows.

* Weapons of any kind can be asked to be removed.

*No Golf Carts or ATV's allowed on the grounds unless being sold.

Flea Market Information and Guidelines

- When arriving vendors must use the flea market vendors' gate; this is the most north gate located on N 13 road.
- Check in Monday, Tuesday, & Wednesday the week of the show, from 9am-5pm; and Thursday morning from 6am-9am.
- If you arrive after hours for check in you will have to park in the vendor holding lot across the street from the East Gate.
- Your contract must be signed and account paid in full to begin setting up on your lot(s).
- The show starts promptly Thursday morning at 9am, so you must be set up and able to sell by 9am.
- If you have not called, and/or do not arrive on time your lots will be forfeited.
- Each lot purchase includes 2 weekend show bands. Each additional person pays \$10 for a day band or \$25 for a weekend band.
- Lots are assigned on a first come first serve basis, for information on lot assignment contact Alex.
- Everything must fit within your lot(s) boundaries.
- There is absolutely NO DRIVING in the flea market between 9am-7:30pm.
- There is no parking on empty flea market lots, vendor parking is across the street from the East Gate in vendor holding. Shuttles are available to get you back to the flea market.
- Your vehicle can be parked behind your display on your lot if it fits completely within your boundaries. It CANNOT be moved from 9am-7:30pm.
- All pets must be kept on a leash and within your lot boundaries. They are not allowed in the show area whatsoever. Aggressive animals are subject to be removed from the property. Buckley Old Engine Show is not liable for any action of a vendor's animal, you will be held responsible.
- If camping on your lot(s), your merchandise/display MUST be set up in front of your camp set up. You may not purchase a lot in the flea market for camping. We have camping available on the showgrounds for a one-time \$20 maintenance fee.
- There are no campfires allowed within the flea market.
- Generator curfew is 11pm-6am.
- We do not have electric or water hook up for the flea market vendors. The electric and water is for food vendors only.
- There is to be NO on-site prepared food or drinks sold by anyone not approved as a registered Food Vendor.
- Lots must be left in the same condition as when you arrived. You may be assessed for any damages, or trash left on flea market grounds.
- Trash will be picked up several times a day at the designated trash bins throughout the flea market. Please have boxes broken down and garbage disposed of properly. 25# or less per bag.
- If you chose to have packages shipped to the show grounds, you must sign and pay the C.O.D. charges directly to the carrier. Workers will not be held responsible for any deliveries made to the showgrounds.
- Flea market workers will help get large items up to the office for later pick up by the patrons. We do this ONLY when we have the workers present; sometimes it may take a while or not be available.
- Code of Conduct: Physical or verbal threats or abuse, disruptive behavior, profanity, vulgarity, or persistent abuse of BOES personnel will not be tolerated and may result in expulsion from the flea market.
- Anyone may be asked to leave at the discretion of the Buckley Old Engine Show.
