*Check-in days/times – Monday, Tuesday, & Wednesday 9:00 am-5:00 pm.

*Flea Market Hours - Thursday, Friday, & Saturday 9:00 am–7:00 pm. Sunday 9:00 am–3:00 pm

***Office Hours -Thursday-Saturday 8:00 am-10:00 am**

THE OFFICE WILL BE CLOSED AFTER 10:00 AM EACH DAY

Sunday 9:00 -11:00 am & 2:30 - 5:00 pm

*Gate Hours during the show open from 7:00 am to 9:00 am.
and Sunday, 7:00 am to 3:00 pm.

*You may set up or restock daily, before and after the show.

NO DRIVING IN THE FLEA MARKET DURING THE SHOW.

*Lot size is approximately 20'x20' at \$125.00 per lot for the 4-day show.

*Lot includes 2 show passes per lot purchased

*Vendor camping off your lot is available for an additional \$40.00

*No refunds or exchanges. Checks must be valid on receipt.

*No roving vendors are allowed on the showgrounds.

ITEMS NOT ALLOWED TO BE SOLD OR HOUSED

*No food or drinks (including bottled water) can be sold unless you are a registered Food Vendor.

*No Drugs or Drug Paraphernalia of any kind, including medical marijuana or related accessories.

*No obscene materials of any kind, words, posters, clothing, signs, etc.

*No sale of live animals on the showgrounds.

*No counterfeit branded merchandise or any other illegal items.

*No firearms, ammunition, arrowheads, or crossbows.

*Weapons of any kind can be asked to be removed.

*No Golf Carts or ATVs allowed on the grounds unless being sold.

Flea Market Rules

- When arriving, vendors must use the flea market vendors' gate located on N 13 road. Look for signs.
- Check-in is Monday, Tuesday, & Wednesday the week of the show, from 9:00 am-5:00 pm; and Thursday morning from 6:00 am-9:00 am.
- If you arrive after hours for check-in, you will have to park in the vendor holding area lot across the street from the East Gate.
- Your contract must be signed and the account paid in full to begin setting up on your lot(s).
- The show starts promptly at 9:00 am on Thursday, so you must be set up and able to sell by then.
- If you have not called, and/or do not arrive on time, your lots will be forfeited.
- Each lot purchase includes 2 show bands. Each additional person pays \$10 for a day band or \$25 for a show band.
- Lots are assigned on a first-come, first-served basis; for information on lot assignments, contact Karen.
- Everything must fit within your lot(s) boundaries.
- There is absolutely NO DRIVING in the flea market between 9:00 am - 7:30 pm.
- There is no parking on empty flea market lots; vendor parking is across the street from the East Gate in the vendor holding area. Shuttles are available to get you back to the flea market.
- Your vehicle can be parked behind your display on your lot if it fits completely within your boundaries. It CANNOT be moved from 9:00 am-7:30 pm during the show.
- All pets must be kept on a short leash (no longer than 6') and within your lot boundaries. They are not allowed in the show area whatsoever. Aggressive animals are subject to being removed from the property. Buckley Old Engine Show is not liable for any action of a vendor's animal; you will be held responsible.
- If camping on your lot(s), your merchandise/display MUST be set up in front of your camp setup. You may not purchase a lot in the flea market for camping. Camping is available on the showgrounds for \$40 during the show week.
- There are no campfires allowed within the flea market.
- Generator curfew (quiet hours) is 10:00 pm - 7:00 am. Maximum 68 dB noise level allowed during non-generator curfew.
- We do not have electric or water hook-ups for the flea market vendors. The electricity and water are for food vendors only. Any flea market vendor who plugs into an electrical outlet will be asked to leave.
- There is to be NO on-site prepared food or drinks sold by anyone not approved as a registered Food Vendor.
- Lots must be left in the same condition as when you arrived. You may be assessed for any damages or trash left on the flea market grounds.
- Trash will be picked up several times a day at the designated trash bins throughout the flea market. Please have boxes broken down and garbage disposed of properly. 25# or less per bag.
- If you choose to have packages shipped to the showgrounds, you must sign and pay the C.O.D. charges directly to the carrier. Workers will not be held responsible for any deliveries made to the showgrounds.
- Flea market workers will help get large items up to the office for later pick up by the patrons. We do this ONLY when we have the workers present; sometimes it may take a while or not be available.
- Code of Conduct: Physical or verbal threats or abuse, disruptive behavior, profanity, vulgarity, or persistent abuse of BOES personnel will not be tolerated and may result in expulsion from the flea market.
- Anyone may be asked to leave at the discretion of the Buckley Old Engine Show.
